#### Scope of Work

Project Title: Enhancing Evidence-Informed Decision-Making for Improved Childcare Ecosystem in

Kenya

Location: Nairobi, Kisumu, and Vihiga Counties, Kenya

#### 1. Project Background

The International Center for Research on Women (ICRW) is implementing a participatory research and policy engagement initiative aimed at strengthening the childcare ecosystem in Kenya. Focused on Nairobi, Kisumu, and Vihiga counties, this research will generate high-quality evidence and actionable solutions for policymakers, childcare providers, and households.

Women-owned childcare enterprises, primarily informal, are pivotal in meeting the childcare needs of marginalized households. However, these services face severe challenges: under-resourcing, poor regulation, inadequate safety and health standards, and limited government engagement.

The project seeks to produce robust data to inform policy decisions and build capacity for systems-level change, directly enhancing women's economic empowerment and improving children's health and social outcomes.

## 2. Study Objectives

- a) Map and profile women-owned childcare enterprises in Nairobi, Kisumu, and Vihiga counties, documenting their characteristics, services, and challenges.
- b) Document unmet childcare needs of poor and marginalized households and explore actionable strategies.
- c) Identify policy and programmatic options to strengthen women-owned childcare services at county and national levels.
- d) Foster a learning ecosystem through participatory research and embedded learning with key stakeholders.



ICRW is seeking the services of a highly experienced research firm, with technical expertise (quantitative and qualitative) and adequate human resource to undertake the primary data collection, analysis, synthesis, and presentation of findings in a comprehensive report, working closely with the ICRW project team.

### 3. Scope of Work

The selected consulting firm will work closely with ICRW to undertake the following tasks:

- Develop an inception report, detailing the methodology, tools, data collection plan, and work schedule.
- Recruit and train adequate field researchers/enumerators, ensuring familiarity with research tools, ethics, and data protocols.
- Conduct mapping of women-owned childcare enterprises.
- Pilot test tools and incorporate feedback for finalization.
- Execute household surveys (targeting approximately 543 households across the three counties).
- Conduct qualitative data collection:
  - Key Informant Interviews (KIIs) with policy actors and childcare stakeholders.
  - In-Depth Interviews (IDIs) and Focus Group Discussions (FGDs) with women entrepreneurs and marginalized households.
- Ensure digital data collection platforms are used (e.g., CAPI, ODK) for efficiency and accuracy.
- Prepare and share qualitative data matrix, audio recordings, transcripts, codebook, and clean datasets.
- Analyze data and prepare preliminary findings.
- Present preliminary findings to ICRW.
- Validate findings with key actors.
- Develop and submit a comprehensive final study report, including policy recommendations and a slide deck.

# 4. Deliverables

The consultancy firm selected for this assignment would be expected to deliver on the following:

• An inception report including a responsive and clear methodology and data collection plan, analysis plan and a detailed work plan.



- Recruitment and training of adequate number of own Researchers/Assistants to undertake data collection
- Training report on ethics and data collection tools as per approved study protocol
- Pre-testing report with results of the field pilot test including the revised survey questionnaire and qualitative data collection guides for approval and acceptance by the project team.
- Qualitative data matrix/coding framework, code book, audios, and transcripts
- Access to Android data collection platform and codes for programming individual level survey tool
- Raw and clean data sets, recordings, copies of informed consent forms, output files submitted to the ICRW technical team in a format readable by common statistical software e.g., NVIVO, SPSS, Stata e.tc and exported to Excel file as well.
- Draft report of the study for review and input by the ICRW team.
- Presentation of preliminary and final findings to ICRW team
- Validation of the study findings with ICRW and other selected stakeholders; and
- Final study report including the slide-deck.

# 5. Qualifications of Consulting Firm

- Minimum 7 years of experience in mixed-method research, especially in Kenya.
- Expertise in household surveys and qualitative research (KIIs, IDIs, FGDs).
- Demonstrated experience in research on childcare, women's economic empowerment, gender equality, or similar themes.
- Team leads (qualitative and quantitative) with Master's/PhD in Social Sciences, Gender Studies, Public Policy, or related fields.
- Capacity for rapid deployment and data collection in Nairobi, Kisumu, and Vihiga counties.
- Proven ability to deliver high-quality analytical reports in English.
- Proficiency in data collection and analysis software: NVIVO, Stata, SPSS, or equivalent.
- Strong facilitation, mobilization, and interviewing skills.
- Ability to use digital data collection tools (ODK, KoboCollect, etc.).
- Prior experience in engaging with government stakeholders and policy actors is an advantage.

    - Sample of qualitative coding framework.
    - Samples of written or published research reports and products.
